Agreement for the provision of an examination centre

An agreement was entered on...23/03/2016..which corresponds to...15/06/1437....between

whereby the two parties had the following agreement with regards to conducting examinations:

The first clause: The second party **Plymouth Islamic Education Trust (PIETY)** undertakes to prepare the required examination halls according to the standards that are set by the university

The second clause: This agreement is limited to the services agreed upon in clause three, and does not relate to any type of association except what is mentioned in this contract.


The third clause: The second party **Plymouth Islamic Education Trust (PIETY)** undertakes the following:

- To provide computers which are equivalent to the number of students who are expected to be present for the examinations according to the report provided by the first party. There should be standby computers equivalent to 25% of the expected number of students. The examination shall not be written on paper except in times of necessity, and this should happen after consultations with the first party, in a situation where the first party can accommodate such a scenario. Examinations should be held every day according to the examination timetable except for Fridays.
- The examination centre should provide an internet connection whose speeds are not less than 4G.
- There should be separate sitting arrangements for male and female students
- There should be a proctor for males, and another one for females.
- All examinations should be supervised.
- The examinations should be held at the stipulated times.
- The proctor should be present in the examination hall throughout the examination period.
- The student should not be allowed to have a book, notebook, or laptop during the examinations.
- Any problems arising during the examination days should be directed to the people who are responsible for examinations at the university.
